<p>must keep the pressure up on Gatwick and the Secretary of State through the CAA and a deeper pocket will enable us to do this much more effectively and with a far greater chance of success.</p> <p><b>With the announcement of a THREE RUNWAY Gatwick Airport Master Plan in October the task ahead has grown enormously</b> and it is imperative that we are ready for action. We have already had to produce leaflets to hand out at the Gatwick promotion exhibitions, to advertise to remind the general public of the dangers that lie ahead and now to prepare more comprehensive literature for concerned parties - and our finances are running low so we would ask you to donate urgently to enable us to continue to protect our counties.</p> <p><b>We thank you for the generosity over the years which has enabled us to carry out substantial work on your behalf</b> to ensure that Gatwick Airport, the Civil Aviation Authority and the Secretary of State are aware of the <b>damage being done to the lives of those who live in rural areas of Sussex, Surrey and Kent</b> since our inception in 2014 -and now the even greater threat of an airport larger than Heathrow as it is today on our doorstep.</p> <p>We would like to think that a contribution of £10 – 20 per member would not be unreasonable, or whatever you feel you would like to contribute, and this can be done in a number of ways:</p> <p><b>Finally, we are anxious to add some additional members to our committee.</b> You do not have to know about aviation but have a very real desire to help your family and the community combat the expansion of Gatwick airport and the resulting noise and damage to the countryside.
