<p><b>Gatwick Master Plan</b> Email dated 23<sup>rd</sup> October 2018, from CAGNE</p> <p>Gatwick's Master Plan gives you just 12 weeks to respond, over the Christmas period, up to <b>5pm on 10<sup>th</sup> January</b> providing you with eleven loaded questions to respond to.
