2510/18 APPROVAL OF THE MINUTES FROM THE PLANNING COMMITTEE MEETING

2610/18 PUBLIC FORUM

A member of the public spoke of his continuing frustrations with the Micklepage applications and asked whether it was time to 'widen the remit'? The issues have continued for three years, is it now time to address the problems being experienced with the Planning Department? If the application is approved it would have dire consequences for Neighbourhood Plan.

2810/18 PLANNING UPDATES

i) DC/18/1792 Coolhurst Close

The Parish Council strongly objected to the application for a further 5 dwellings on the site. HDC advised that they were having difficulties with the application because the nine to twelve dwellings in the Neighbourhood Plan were not in 'bold type', this has been followed up with a report which concludes the application is 'acceptable in principle'. It was noted that the Case Officer also provided 'pre-application advice'.

RESOLVED to submit the Parish Councils supplementary comments to the Head of Planning Emma Parkes, District Councillor Toni Bradnum and the Case Officer and arrange a meeting with Emma Parkes to discuss the implications of the report (Appendix DC/18/1792).

The Neighbourhood Plan consultant, Neil Homer, has advised there is no evidence that the font of the type can be considered, the policy would have stated nine to fifteen houses is that was what was wanted and the nine to twelve houses were not challenged by HDC or the Independent Examiner.

Nuthurst were the first Parish to complete a Neighbourhood Plan in the district and HDC had not completed the HDPF, lessons have been learnt and will be picked up when the Neighbourhood Plan is reviewed at some time in the future.

The Chairman advised that the members comments on the pressures between HDC and developers and the 'Made' Neighbourhood Plan' not being considered were noted and would be addressed at a later date.

ii) Meeting with Barbara Childs, Director of Place

The Chairman and Cllr Owen Hydes had a meeting with Barbara Childs, Emma Parkes and Aimee Richardson to discuss DC/18/1792 and the Neighbourhood Plan.

The meeting was beneficial, it was stressed that the Neighbourhood Plan was part of the HDPF, that the Parish Council wanted to work with the Planning Department and provide local knowledge and that meetings would take place on controversial applications prior to the officer writing their report.

iii) DC/18/1883 & DC/18/2076 Micklepage

The members are in receipt of a letter dated 8th October from Greenplan and the following response has been sent to the Planning Department:

'The Parish Council made a proper and democratic decision to object to DC/18/1883. It is felt that the decision cannot and will not be overturned and that Councillors would not agree to anything that would contravene the Nuthurst Parish's legally made Neighbourhood Plan.

Furthermore, it should be noted that Greenplan's appeal application form addressed to the Planning Inspectorate did NOT tick the box for "with costs".

Greenplan have written a further letter to the Planning Department on 17th October 2018, the Clerk was copied in on the correspondence and it is not for the Parish Council to respond.

The Chairman thanked Cllr Owen Hydes for his continued assistance with the planning issues in the Parish and commented that 'it may seem that we are not being forceful enough, but, we have got to continue working with the Planning Department'.

2910/18 MINOR MATTERS RAISED BY COUNCILLORS TO BE REFERRED TO ON THE NEXT AGENDA

The obstructions on the verge outside Old Park Farm Cottage have still not been removed, the Clerk will report to Highways again.
