K6 Phone Box competition 2018 / 2019



At its meeting on 18th April, The WSALC Board was delighted to welcome the winners of the K6 phone Box competition, organised in association with Sussex Heritage Trust. The award ceremony was hosted by the WSALC Board this year because all three winning entries came from within the County.

In first place and awarded a SSALC voucher for £500 was Ansty & Staplefield PC with its imaginative entry of '*Brook Street Library*' - an adaptation that not only accommodated shelves of books but two folding seats.

Second place and a £300 voucher was awarded to Parham PC for its '*Greatham Poetry Booth*' entry, echoing the literary legacy for which the area is renowned.

In third place and a £100 voucher was Sutton & Barlavington PC with its well stocked and conveniently sited '*Information Point*' aimed at walkers and cyclists many of whom drop down from the South Downs Way and into this very small community.

Chichester architect and artist Neil Holland was present to represent the Heritage Trust, Neil commended the winners for their imagination and measures to preserve an iconic feature of our countryside.

WSALC President, Michael Chater presented the awards and hoped this would encourage many more entries for this years competition.

WSCC's community funding window closes 28 May

We need your help in making communities aware of next month's deadline to apply to the Community Initiative Fund (CIF).

Eligible groups are encouraged to create a crowdfunding campaign and pitch to CIF via [West Sussex Crowd](#) by Tuesday 28 May.

In the platform's first year, more than £420,000 in pledges has been generated across all campaigns – of which over £237,000 was donated by residents, local businesses and partner funds.

The county council has so far awarded £174,676 to 75 successful campaigns West Sussex-wide.

In order to be eligible for consideration at the next County Local Committee meeting, proposed projects must intend to use funding towards:

- Purchase of equipment;
- Venue or equipment hire;
- Building works, renovation or repair;



- Advertising/promotion for a community event.

A brand new mobile app has launched to help members of the armed forces community in West Sussex and the south east access support.



The free Forces Connect app is aimed at serving personnel, veterans, and their families as well as public sector organisations to help them find local services and organisations offering support.

The app was commissioned by Forces Connect South East, a partnership comprising West Sussex County Council, and the councils of Surrey, Kent, East Sussex, Brighton and Hove and Medway and Sussex NHS which secured Ministry of Defence grant funding for projects which make it easier for military personnel to access support.

Its purpose is to improve the health and wellbeing of residents, and reduce the gaps in health and wellbeing between communities, while ensuring joined-up working across services.

West Sussex Civilian Military Partnership



Meeting with housing minister

Our chairman, Cllr Sue Baxter, and head of policy and communications, Justin Griggs, met the housing minister, Kit Malthouse MP, this week, primarily to discuss neighbourhood planning. You can read our news story [here](#), and below is a more detailed summary:

- Sue welcomed his engagement with NALC and the Hampshire Association of Local Councils, in particular through Lobby Day, outlining the important role of local (parish and town) councils in building strong communities and potential to help government and the country tackle the challenges it faces, but to make the most of this opportunity we will need help from principal councils and government, particularly through the Comprehensive Spending Review
- NALC is a longstanding supporter of neighbourhood planning but wants neighbourhood plans to be given more weight and protection, Sue highlighted [Where next for neighbourhood plans?](#), which had previously been sent to the minister
- Sue pressed for greater involvement in the supporting programme run by Locality, and for this to be opened as soon as possible, but also requested parallel direct work with NALC and county associations to promote and support neighbourhood planning
- Issues the minister raised included refreshing and renewing neighbourhood planning including slimming down the process (you can read more in his *LCR* article!), relationships with principal authorities and tensions with neighbourhood planning groups, the challenge of getting communities feeling more in control of development while balancing the overarching need for more housing, and local councils directly or working with others to provide housing

- It was agreed to work together on visits to councils and a roundtable to learn from our councils about their neighbourhood planning experience, and involvement in the review of neighbourhood planning including research which is due to be tendered shortly

On the neighbourhood planning support programme, the government did anticipate opening for grant and technical support in early April but due to the local elections were restricted by the pre-election period. This may affect qualifying bodies including local councils looking to claim from the programme in the current financial year, which we raised with the minister, but more information on the 2019/20 support programme is expected soon!

Lords report on the rural economy

I was pleased to see a House of Lords Select Committee back [NALC's call for a rural strategy](#) in their report on the rural economy and also support our longstanding policy objective on council tax referendums! Hugely welcome also was the recognition of our role in supporting local economies where the report said: *"Town and parish councils should be encouraged to use their discretionary powers to promote local growth through strategic investment, asset management and service delivery"*. Sue attended a roundtable event on 1 May hosted by the Committee's chairman Lord Foster for stakeholders to discuss the report.
