Thank you for coming in and presenting your proposal for a disability inclusive centre for Mannings Heath Golf Club that could be accessed by day service providers, children with special educational needs, dementia/elderly services and families of deprived and disadvantaged backgrounds.

It was fantastic to meet you both and I was so impressed and overwhelmed by your drive and the achievements you have both made by highlighting the need for additional community activities and bringing accessible golf for people with Learning Disabilities and autism through your 'not for profit' organisation ,Warren Clark Golfing Dreams. We are very excited with how your proposal brings golf and its associated skills to people of all abilities with the innovative and inclusive equipment and opportunities you already provide.

Our school, Queen Elizabeth II Silver Jubilee School is situated in Horsham and caters for pupils with severe or profound and multiple learning difficulties, or complex needs. There are 106 pupils on roll aged 2-19 years, with 15 teachers, 5 higher level teaching assistants and 40 special support assistants in ten class bases.

It was fantastic to hear your proposal with an insight as to what you want to achieve. Our students are lucky enough to access some community activities but this is not always possible with the levels of need of some students and lack of accessibility. With the prospect of an inclusive gym, hydrotherapy pool, accessible 9-hole golf course and tennis/multi-sports it would give all our students the potential to learn new skills and develop their confidence in the local community. The opportunity of work experience, future employment and linking this through community transition is extremely exciting.

The school would be more than happy to support you with your proposal and would look forward to working with you to make this dream a reality for yourselves and all those who would benefit from this fantastic venture.

The benefits to people with disabilities outlined in your proposal such as offering accessible changing facilities, quiet areas, access to catering facilities and sensory rooms coupled with the benefits to people's positive mental health, physical awareness, inclusion and public awareness of disability sport are not available to people in Horsham or the surrounding areas at this time. This is without doubt an opportunity to bridge a gap in the community for people with learning disabilities and autism.





(Starting New At Golf)

We would be very happy to support you with your proposal and work with you to make it a success.

The Strawford Centre is a busy service for adults with a wide range of learning and physical disabilities. We offer placements to people from the age of eighteen and currently have 70+ people on our register.

A majority of people who attend our service appreciate and enjoy participating in activities that promote their health, wellbeing and community presence. However, there are very limited affordable facilities for people who use our service within the Horsham area. Common difficulties that the majority of people who use our services have are the financial constraints of their budgets. Everyone who attends the Strawford Centre relies on benefits such as PIP and once they have paid their contributions to housing, transport and day services, have a very small budget to enjoy extracurricular activities.

The benefits to people with disabilities outlined in your proposal such as offering accessible changing facilities, quiet areas for people, access to catering facilities and sensory rooms coupled with the benefits to people's positive mental health, physical awareness, inclusion and public awareness of disability sport are not available to people in Horsham or the surrounding areas at this time. This is

without doubt an opportunity to bridge a gap in the community for people with learning disabilities and autism.

We have discussed your proposal with people who attend our service and also some parents and carers who have all expressed a lot of interest in supporting you in your endeavours to bring Accessible golfing and other activities to the local community. They appreciate your proposal to make your project affordable and inclusive not only to people with disabilities but to their siblings also.

The work that Warren and you have done in promoting what can be seen as an exclusive sport in such an inclusive way is truly inspirational. Should you be successful in your venture at Mannings heath Golf Club we as a service would certainly include the opportunities you outline in your proposal in our regular timetable and promote Warren Clark Golfing Dreams to all our stakeholders.


