**Consent is granted to install approx. 16m length of fencing on the south side of the parking area, junction of Brighton Road and Pound Lane, Mannings Heath.**

The above proposal is approved subject to the following conditions:-

- (1) **FORM OF INDEMNITY** – The form overleaf shall be completed by the applicant and no activities or work may be undertaken unless and until the Highway Officer has signed the acceptance on behalf of the County Council.
- (2) **THE WORKS** – All works shall be in accordance with the specific requirements of the Highway Officer and insofar as the site will be subject to periodic inspection additional conditions may be imposed during the works.
- (3) **TRAFFIC CONTROL** – The Contractor shall provide and erect all necessary warning notices, signs and signals for the satisfactory control of traffic in accordance with the "Traffic Signs Regulations and General Directions 1981" and any subsequent amendments thereof.
- (4) **DISABLED AND BLIND PERSONS** – All works shall be executed with due regard to the additional particular needs of Disabled and Blind Persons using the highway
- (5) **ROAD SIGNS** – No existing road sign/line shall be obstructed or rendered less effective due to the execution of works without the approval of the Highway Officer and the provision of alternative signing/lining to his requirements.
- (6) **DEFAULT** – In the event of the works not being to the entire satisfaction of the Highway Officer the works shall cease and the original conditions shall be restored forthwith. If necessary, the restoration of works will be carried out by the County Council and the cost shall be recoverable from the person of persons responsible.
- (7) It is the responsibility of the applicant to consult with the Local Planning Authority to determine whether a planning approval is required for these works.

**SPECIFIC REQUIREMENTS OF HIGHWAY OFFICER**

- (8) Proof of £10 Million Public Liability insurance is required before consent will be given.
- (9) Works to be carried out by a NRSWA operative in the presence of NRSWA supervisor.
