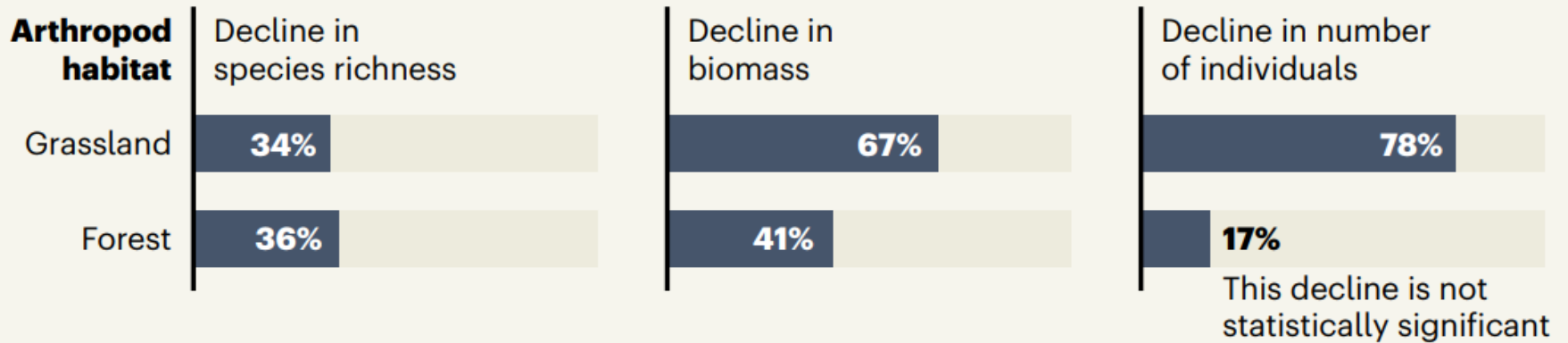
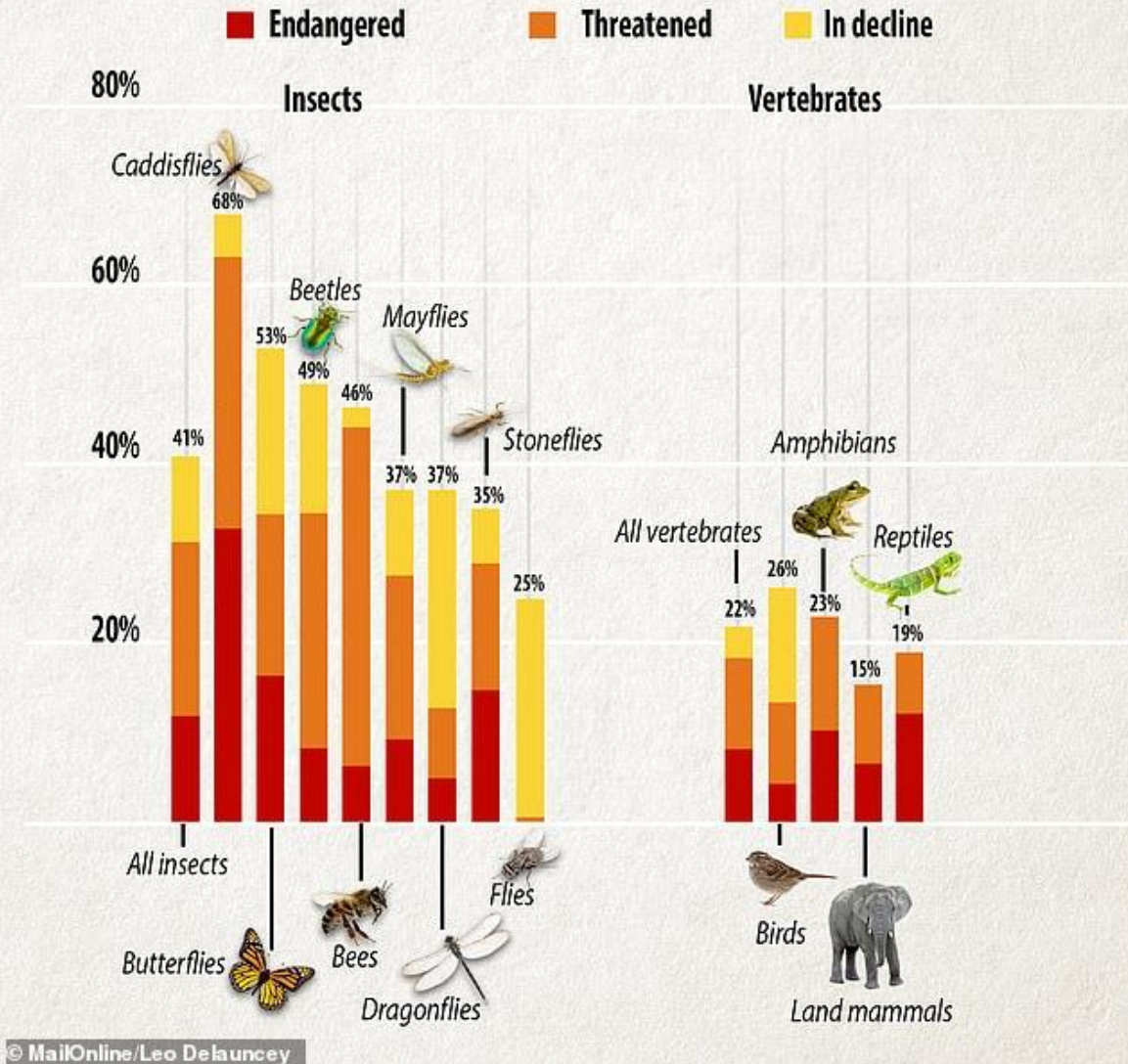


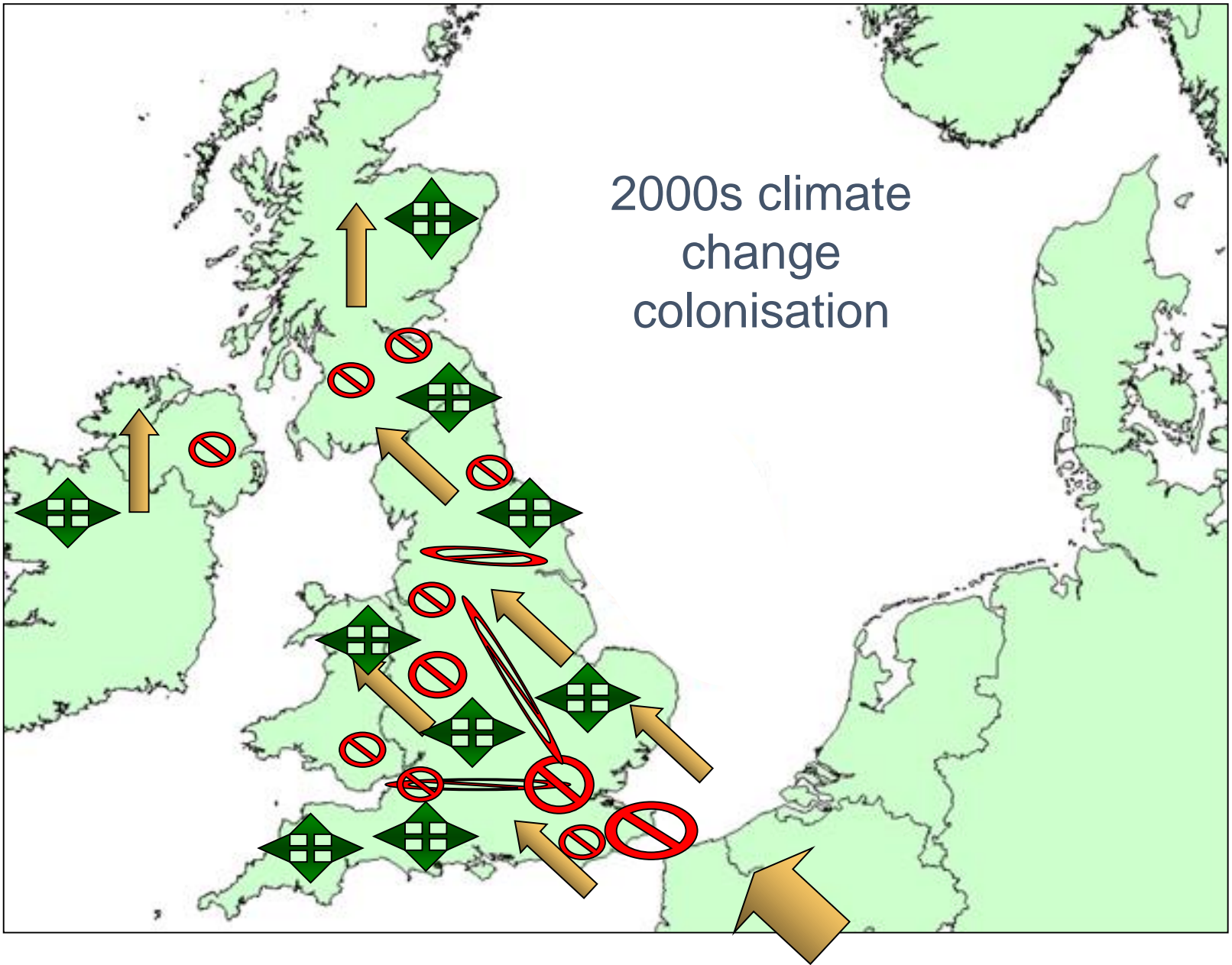
Figure 2 | Arthropod declines recorded in Germany. Seibold *et al.*¹ report nearly a decade’s worth of standardized sampling of arthropods – jointed invertebrates such as insects – at grassland and forest sites. The authors provide compelling evidence of declines in arthropod populations over time. These large-scale changes will probably have a negative effect on key ecosystem services such as pollination. Seibold and colleagues found that species richness and biomass declined significantly during the course of the study in both types of habitat, as did the number of arthropod individuals recorded at grassland sites. The decline in arthropod population sizes noted at forest sites was not statistically significant.

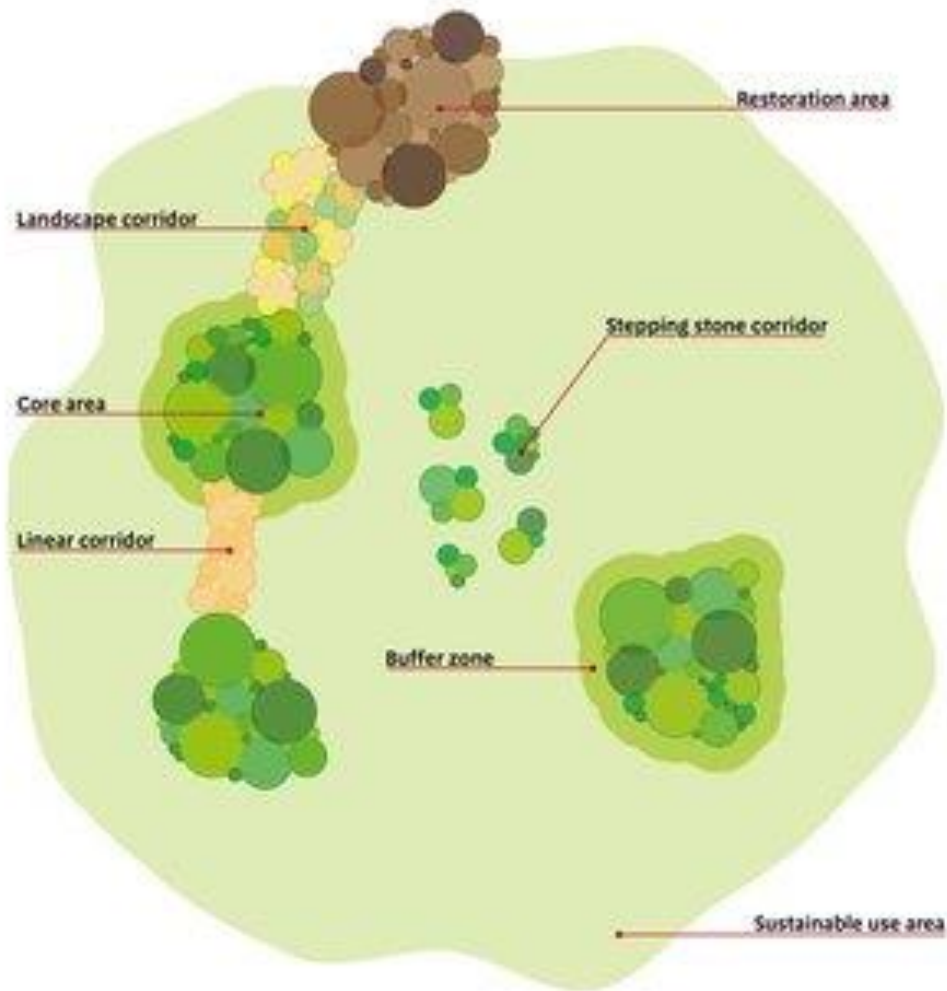

- We need nature to thrive and to be able to move through the District.

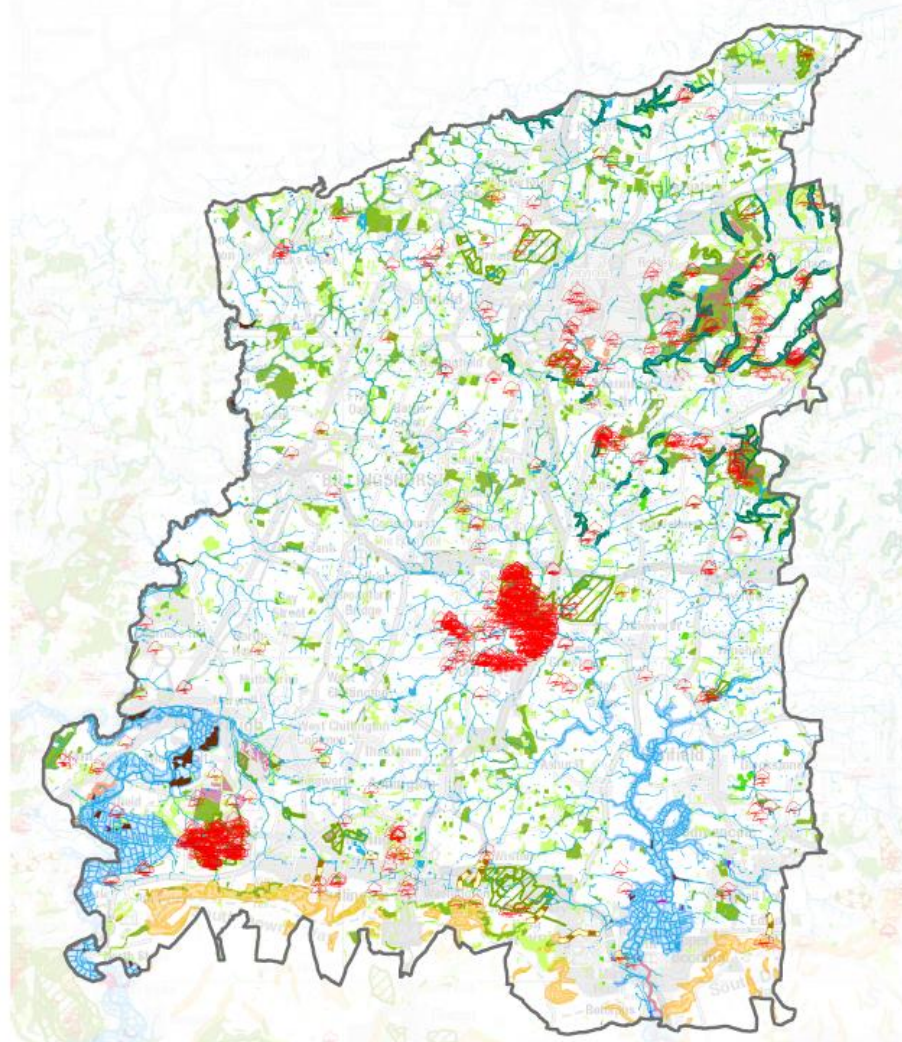

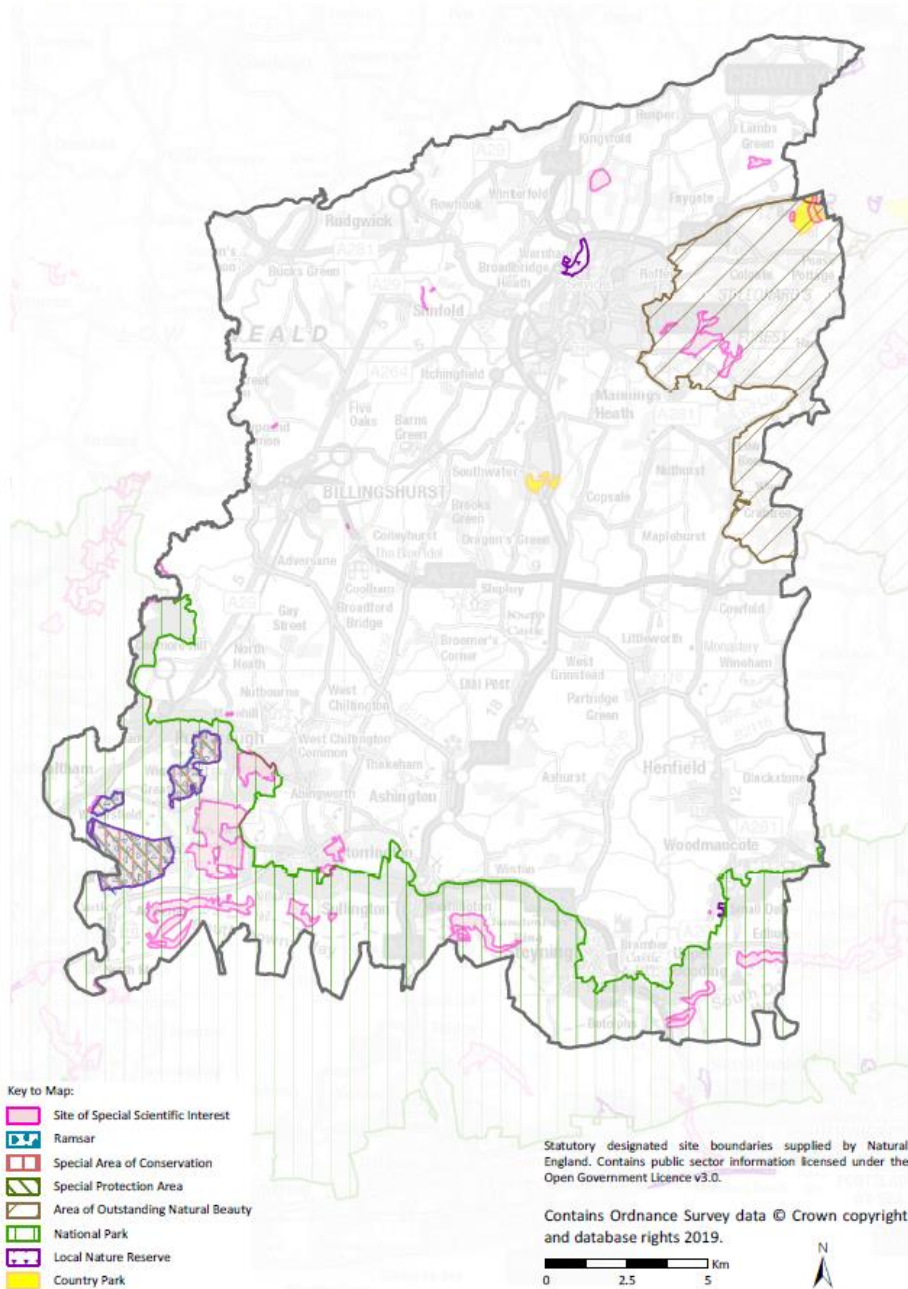

Land at Horsham District

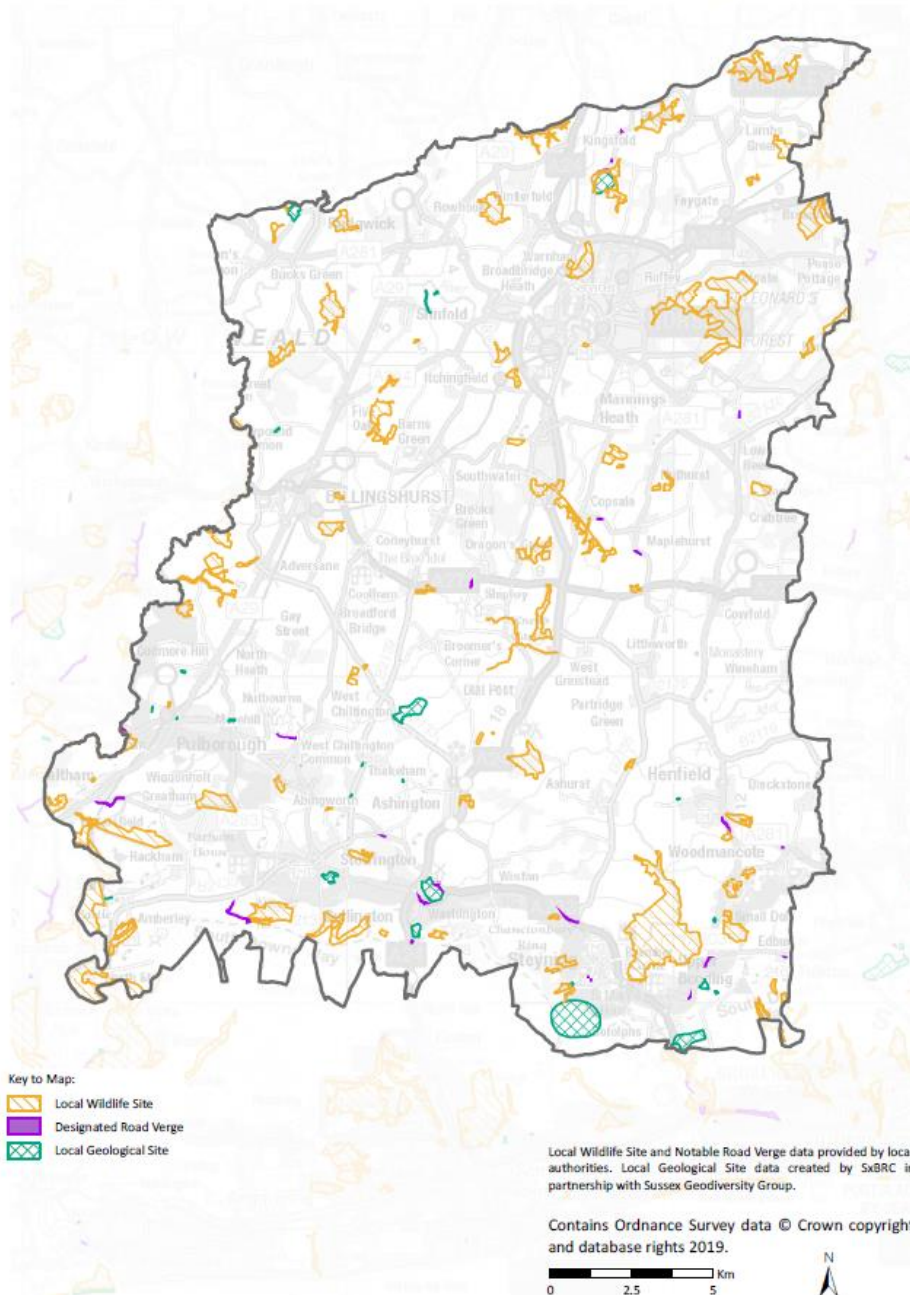

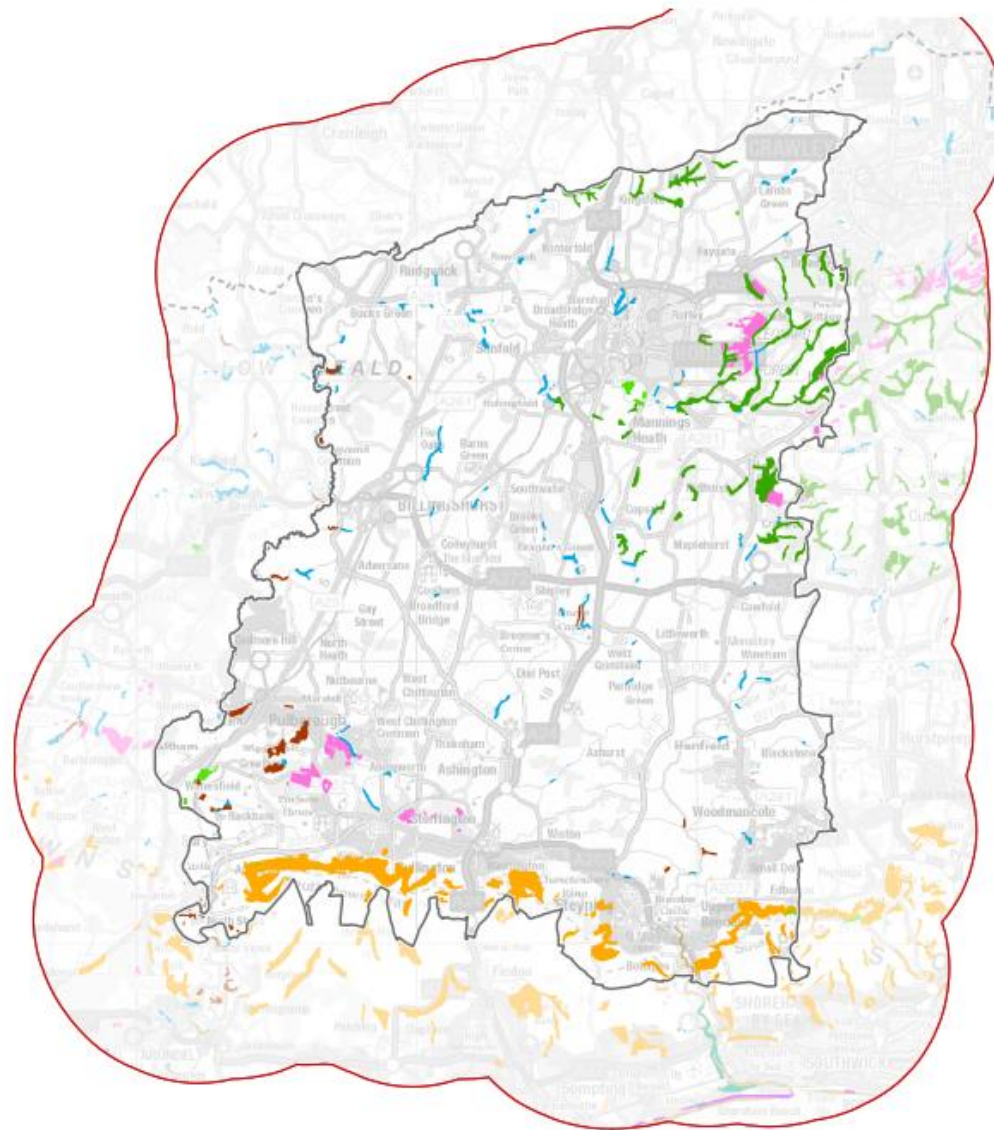


Map 2: Non-statutory site designations

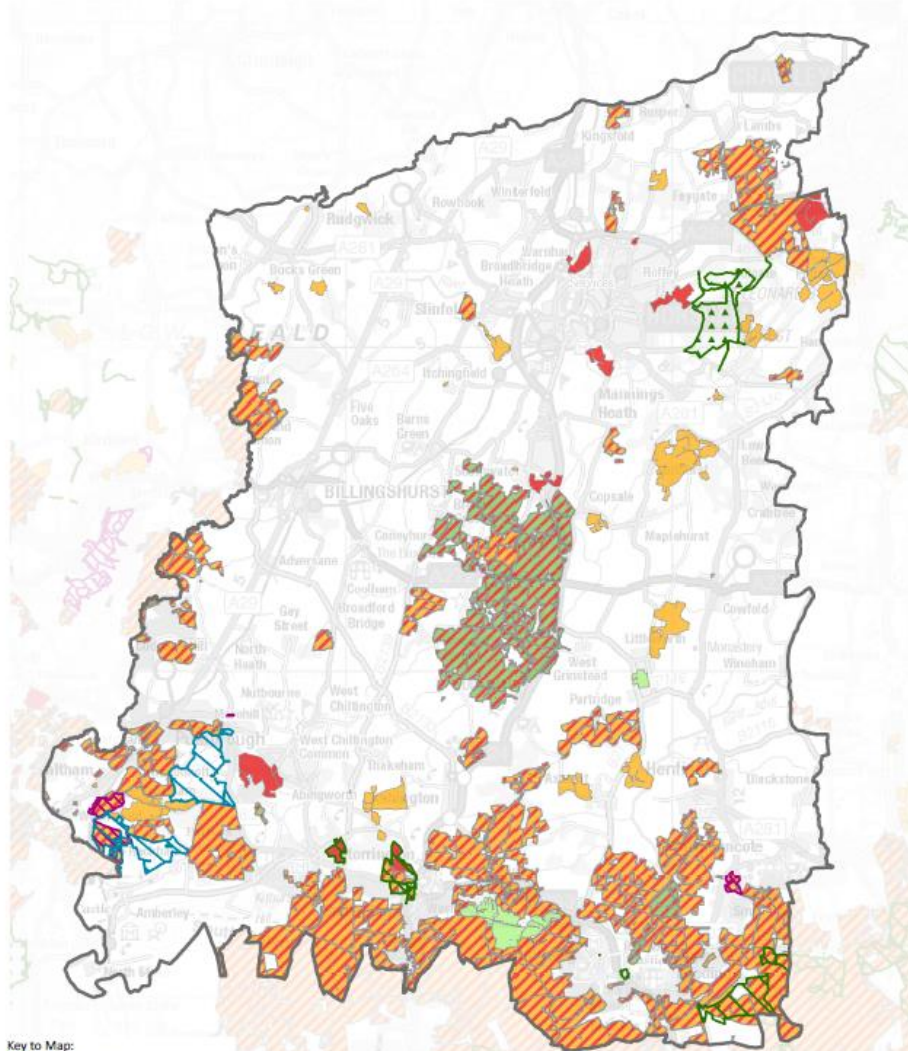

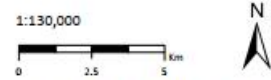

Natural Capital Investment Areas: a clean water environment.

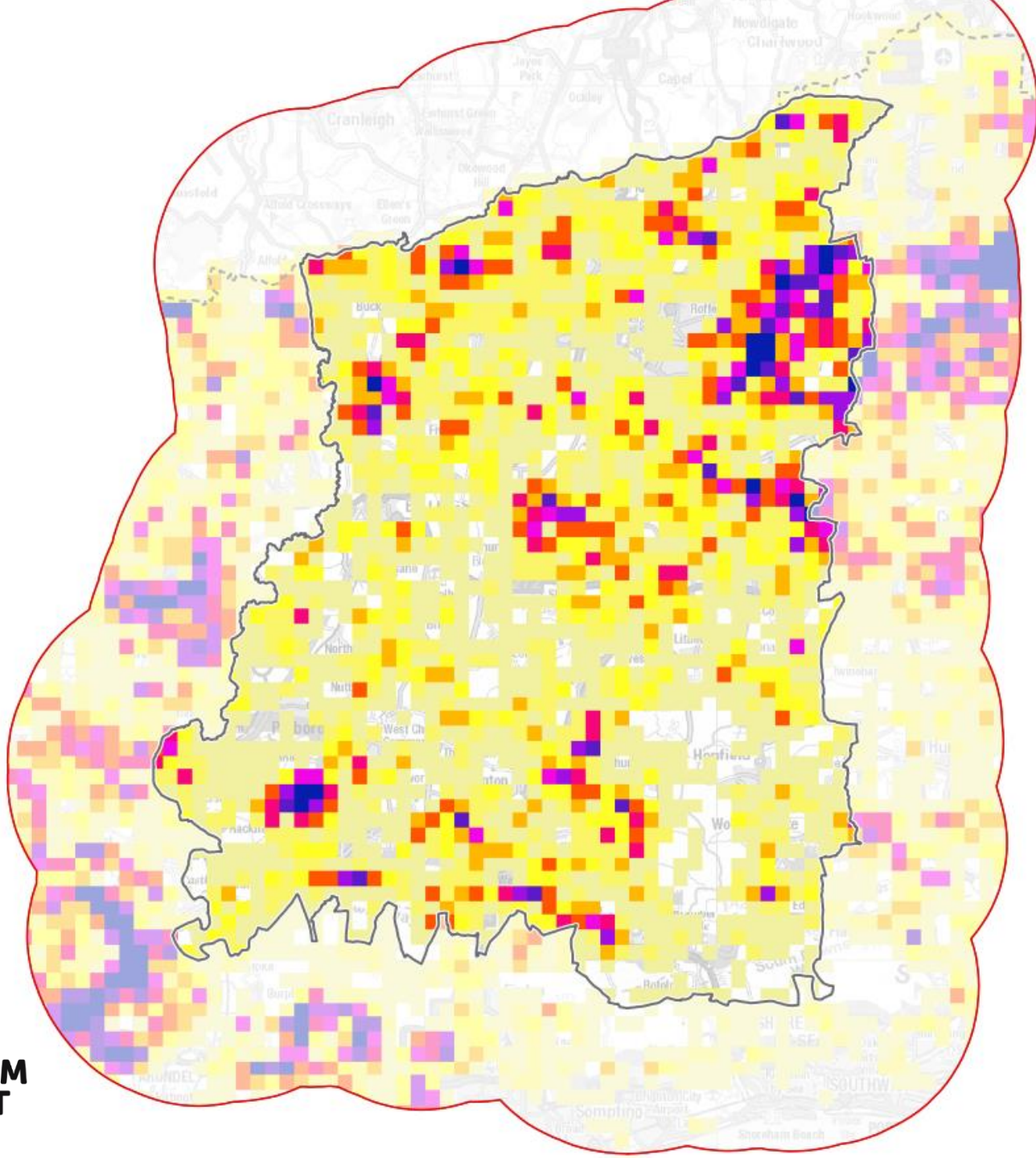

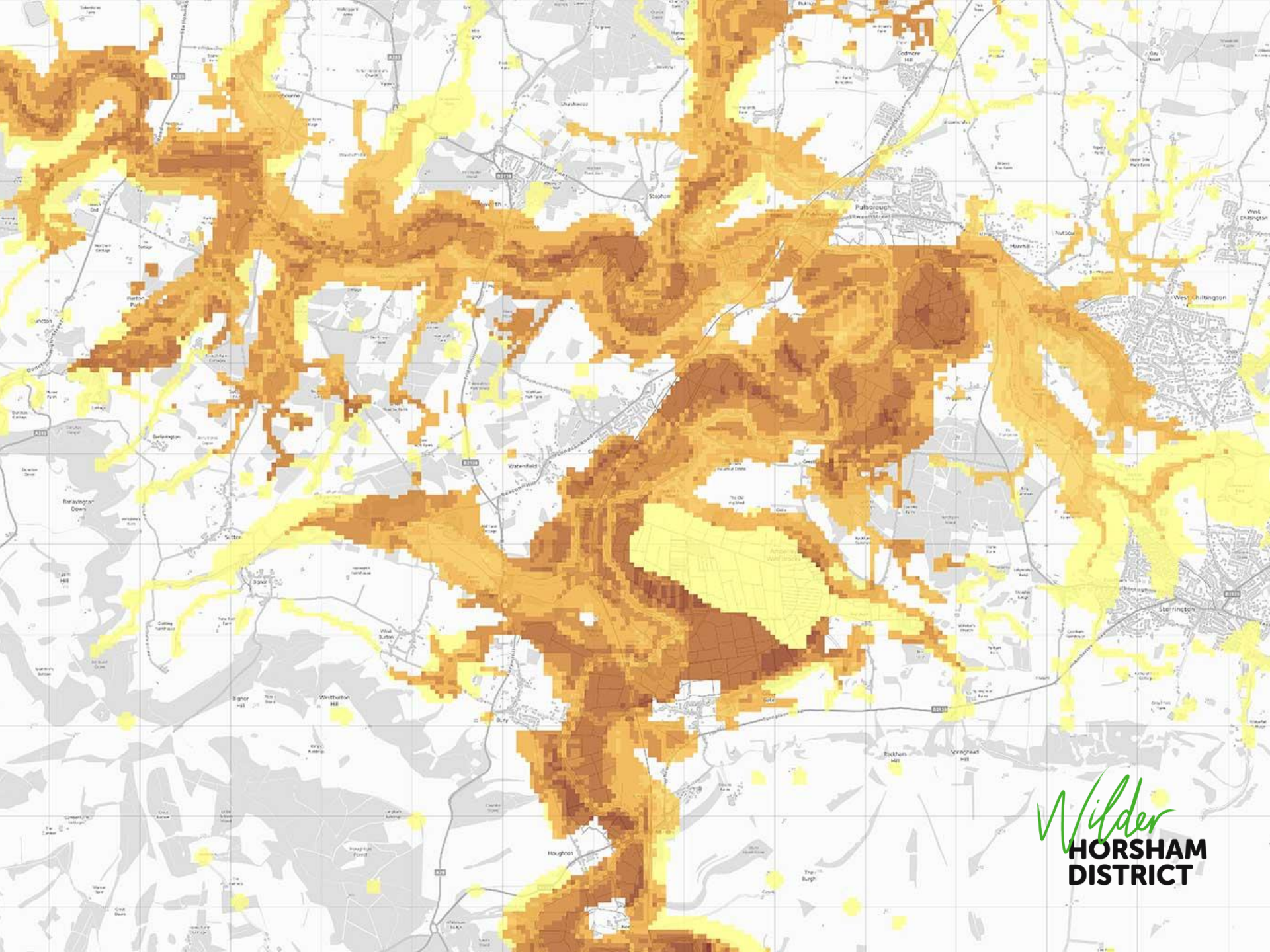
